CALL TO ORDER

Pursuant to public notice, the meeting commenced at 1:01p.m. with a Call to Order by Chair, Valora Cole. Roll call was taken, and quorum established. Ms. Cole thanked the board for their service and for attending during this challenging time.

Legislative Update

Mr. Jon Hage, CEO of CSUSA, reported the Florida legislative update which included that
the Governors teacher compensation initiative was signed and will be implemented in
the 2020-21 school year budget. Mr. Hage advised that that if the legislature is called
back into special session due to the COVID outbreak, that the lobbying firm and CSUSA

- stand ready to protect the Teacher Pay legislation. This legislation will include Charter teachers.
- There were other initiatives, such as security updates, modified language for due
 process and, simplifying the dual enrollment payment option as historically, the College
 would take the FTE payment but now there is a makeup provision that will allow dual
 enrollment opportunities.

CSUSA Update

Jon Hage, CEO of CSUSA, updated the board on the state of CSUSA given the COVID 19 Crisis and online learning that the schools have transitioned to. Mr. Hage reported that the CSUSA managed schools have been able to ensure that education rigor will be maintained and while there will be no FSA State testing, CSUSA managed schools will continue to educate as if testing were a requirement. CSUSA will have its own assessment tools that it will use.

I. ADMINISTRATIVE

Annual Meeting

The Board discussed the election of officers. Ms. Cole called for nominations of Chair.

II. CSUSA REPORTS

COVID Response

Dr. Eddie Ruiz update the board on the status of CSUSA and the COVID Response.
 CSUSA has a COVID Response team that meets daily to discuss the issues with all the
 functional departments. Ana Cordal has been heading up the COVID Response team
 from the National team and Dr. Ruiz and Mrs. Cordal meet daily to discuss what the
 leadership is reporting out. Dr. Ruiz also participates in the FLDOE State Superintendent
 call.

Online Learning Update

- Dr. Ruiz expanded on the COVID Response report that the Online Learning Instructional Continuity Plan that the board received has been implemented across all the CSUSA managed schools for the Board. The plan includes feedback from all Stakeholders and was drafted with the Principals of each school. Dr. Ruiz advised that the plan is continuing to evolve based on the decisions of the FLDOE.
- Eric Johnson reported out to the board that he has personal experience with Winthrop Charter School and has been impressed with the roll out of online learning.

2020-2021 School Year Calendars

 The board reviewed the 2020-2021 School Year Calendars for their schools in Hillsborough, Dade, Clay, and Pasco counties which included specific calendars for Innovation Prep Academy in Pasco County and Winthrop Prep Charter Academy. The board noted the differences within the district calendars.

MOTION: A motion was made by Eric Johnson and seconded by Dr. Ramdas Chandra to approve the 2020-2021 School Year calendars, as presented. Motion passed unanimously. (6-0)

- Eric Johnson wanted to say he appreciates the move to digital marketing for enrollment given the current situation in the state with COVID-19.
- Lane Morris wanted to let the board know that UPCA was able to virtually interview and finish the application for Cambridge and said that Principal Morales and her team were well prepared for the interview.
