 - Parent Raul Silva shared with the board his concern about his daughter being bullied in school and how he was not happy with the way School Administration at Creekside Charter Academy handled the issue.

II. ADMINISTRATIVE

Approval of the April 7, 2022 Board Meeting Minutes

 The board reviewed the meeting minutes of the April 7, 2022, Florida Charter Educational Foundation, Inc. and Bay Area Charter Foundation, LLC. ("FCEF-BACF") Meeting. III. CSUSA REPORTS

State Director Update

 Dr. Eddie Ruiz updated the board on the summer bridge program being held at some of the schools. Principal Leadership Academy is scheduled for June 21 to June 24 where the emphasis will be on professional development and coaching teams to target continually improving student success at each school. School FSA data is anticipated to be released towards the end of June with FLDOE School Grades being released shortly thereafter. CSUSA will report out once the data has been released.
